# MINUTES BUSINESS IMPROVEMENT DISTRICT ADVISORY COMMITTEE OF MONTEREY PARK Special Meeting January 31, 2023

The Business Improvement District Advisory Committee (BIDAC) of the City of Monterey Park held a Special Meeting at City Hall, Conference Room #102, located at 320 W. Newmark Avenue, Monterey Park, CA 91754, on January 31, 2023, at 4:00 pm.

#### **CALL TO ORDER:**

Chairperson Chair Elizabeth Yang called the meeting to order at 4:06 pm.

#### **ROLL CALL:**

Interim Economic Development Specialist Sharlene Choy called roll:

#### **ORAL AND WRITTEN COMMUNICATIONS**

 PRESENTATION – Economic Development Manager Joseph Torres advised the Commissioners to complete the Annual Residency Verification form as required to serve in BIDAC.

#### 2. CONSENT CALENDAR

#### 2-A. APPROVAL OF MINUTES

**Action Taken:** The Business Improvement District Advisory Committee approved the minutes from the Regular Meeting of October 20, 2022.

3. PUBLIC HEARING – In response to the tragic event of January 21, 2023, Elaine Pang representing Pacific Asian Consortium in Employment (PACE), engaged the surrounding business owners last week and surveyed to find out what was most concerning to these businesses. Her general findings were 1) Public Safety and 2) Homeless Issues: shoplifting, car destruction, trash, etc.

She also shared that the County of Los Angeles just announced a new Economic Opportunity Grant (EOG), Phase 1, for microbusinesses with under \$50K in

revenue and will be rewarded \$2,500 per grant. In February 2023, Phase 2 will award \$15,000 or \$20,000 per grant for small businesses and \$20,000 or \$25,000 per grant for non-profits. The program will run through May 2023 or when the funds are expended.

Elaine and her team plan to conduct another survey walk next week to further engage the business owners and assess how best to support their businesses.

#### **Action Taken:**

- (1) Based on the findings from PACE's outreach, BIDAC will discuss below possible assistance:
  - a) Offer Public Safety Workshops
  - b) Allocate funds to hire 3<sup>rd</sup> party patrol in the BID area.
  - c) Allocate funds to get security cameras in the BID area.
  - d) Address CODE Enforcement for trash dumping and abandoned cars.
- (2) Staff requested that Elaine Pang get clarification on the County of Los Angeles grant if the assistance is to aid small businesses in general or if it's to target those businesses affected by the shooting incident of January 21, 2023.
- (3) Elaine Pang requested the assistance of Staff and Commissioners to share the news of the grant with the small businesses in Monterey Park.

#### 4. OLD BUSINESS

## 4-A. DEVELOP INCENTIVE PROGRAMS TO PROMOTE ECOMOMIC ACTIVITY WITHIN THE BID

The Commissioners plan several beautification programs to promote economic activity with the BID businesses. One program is funding for BID businesses to beautify and clean up their storefront. Another is funding for students to create mural wall art. Lastly, the Commissioners requested more Municipal Code Enforcement in the BID area.

#### **Action Taken:**

- (1) The Commissioners requested that staff drafts a baseline for the specification needed for BID business to receive funding for their storefront beautification project by the next meeting.
- (2) The Commissioners requested that staff find out the cost of mural permit fees.
- (3) Commissioner Jessy Li requested that staff provide her with the contact for the CODE enforcement department.
