

**DEMENTIA/ALZHEIMER'S KIT USE AGREEMENT  
MONTEREY PARK PUBLIC LIBRARY**

In consideration of being permitted to use and to check out the City of Monterey Park's Dementia/Alzheimer's Kits at the Monterey Park Bruggemeyer Library ("Dementia/Alzheimer's Kits"), I agree to the following:

1. I agree and represent that I have read, understand, and agree to the Library's rules and policies regarding use of the Dementia/Alzheimer's Kits that are set forth below. I understand that if I violate these rules and policies, the Library may revoke or suspend my privileges to use the Dementia/Alzheimer's Kits. I understand that I may appeal the loss of privileges to the City Manager in person or in writing. The City Manager will be the final decision-making authority.
2. I release, waive, discharge, and covenant on behalf of myself not to sue the City of Monterey Park, its elected and appointed officials, agents, volunteers, and employees ("Releasees") from all liability to me for any loss or damage, and any claim or demands on account of personal or property injury, whether caused by Releasees' negligence or otherwise, while I use the Dementia/Alzheimer's Kits.
3. I expressly agree that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the State of California and that if any portion is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

**DEMENTIA/ALZHEIMER'S KIT USE RULES**

- Patrons 18 years of age and older may borrow a Dementia/Alzheimer's Kits Kit for up to three weeks (21 days) and are allowed one additional renewal providing there are no holds on the kit.
- Alzheimer's/Dementia Kits will be circulated on a first-come, first-served basis. If kits are checked out, a hold can be placed on the kits with a valid Library card.
- A valid Monterey Park Bruggemeyer Library card must be presented at the time of checkout. Borrowers must be in good standing with a current address on file.
- Dementia/Alzheimer's Kits must be checked out from and returned to the Circulation Desk.
- Users must accept full responsibility for the kit.
- If a borrower loses any of the accompanying items in the kit, they will be charged a fee of \$9.25.

- If a borrower loses or does not return the kit by the due date, they will be charged a replacement cost of \$140.00 and a \$10.00 processing fee.

By signing this Agreement, I agree that I have read and understand this Agreement, and further agree that no oral representations, statements, or inducement apart from the foregoing written agreement have been made.
