

RESOLUTION NO. 12121

A RESOLUTION ADDING AN INITIATIVE MEASURE TO THE BALLOT FOR THE PREVIOUSLY CALLED MARCH 3, 2020 ELECTION PURSUANT TO ELECTIONS CODE § 9222.

The City Council of the city of Monterey Park resolves as follows:

SECTION 1: Pursuant to Elections Code § 9222, the City Council places an advisory measure on the ballot for the general municipal election scheduled for Tuesday, March 3, 2020 as previously established and implemented by City Council Resolution Nos. 12112 and 12113 adopted on October 16, 2019.


SECTION 2: A copy of the advisory measure to be considered by the voters is attached as Exhibit "A," and incorporated by reference. The ballot measure will be designated as Measure "XX" on the ballots, unless it must be otherwise designated to accommodate the consolidation of the City's election with other elections.

SECTION 3: Pursuant to Elections Code §§ 9222 and 13119 the exact form of the question to be voted on at the election as it should appear on the ballot is as follows:


SECTION 4: This Resolution will become effective immediately upon adoption.





**A PROPOSITION ADVISING THE CITY OF MONTEREY PARK
REGARDING EXPENDITURE OF REVENUE RESULTING
FROM A 3/4 SALES TAX INCREASE**

This measure is NOT a tax. This proposition is a nonbinding advisory measure that states the City of Monterey Park's voters' intent that any new revenue received by the City of Monterey Park as a result of a 3/4 cent sales tax increase be spent, in addition to and not a substitution for other budgeted funds, on the public projects identified below.

- Alley reconstruction;
- Street resurfacing/rehabilitation;
- Sidewalk reconstruction for Americans with Disabilities Act Compliant;
- Traffic signal upgrades to alleviate congestion and improve traffic flow;
- Citywide street lighting, parkway and median maintenance;
- Safety equipment to enhance emergency services;
- Library collections, database, and replacement of public access computers;
- Thirteen Citywide parks rehabilitation projects including:
 - Restroom rehabilitation and improvements to, among other things, complying with the American with Disabilities Act;
 - Park playground equipment to comply with American with Disabilities Act;
 - Irrigation system improvement;
 - Park parking lot reconstruction; and
 - Pavilion and picnic shelter rehabilitation.

Sales tax revenue should not be used by the City Council for general municipal purposes including, without limitation, ongoing public employee salaries. The City may, however, spend a reasonable amount of the sales tax revenue for administrative costs directly related to implementing the public projects listed above.
