Assembly Bill 1826 & SB 1383 both mandate the recycling of commercial organic waste. This means that all businesses and multi-family complexes must have an organics recycling program. Organic waste is defined as: food waste, green waste, landscape, and pruning waste, nonhazardous wood waste, and food-soiled paper waste that is mixed in with food waste. Businesses and multi-family complexes can comply with this requirement by subscribing to the services offered by their refuse service provider or by self hauling their organic waste to a permitted facility.

If you intend to self haul your organic waste rather than subscribe to the service offered by your refuse service provider, you must register with the city by completing and submitting this form.

REQUIREMENTS FOR SELF HAULERS

The requirements for self haulers of commercial organic waste, as defined in the SB 1383 regulations and the city's municipal code are:

1. Organic waste must be separated from other waste and recyclables.
2. The organic waste must be hauled to a facility that is equipped and permitted to accept and process source-separated organic waste.
3. The self hauler must keep records of the amount of organic waste hauled to each facility, and these records must be made available for inspection by the city or its designated representative. The records must include delivery receipts and/or weight tickets that indicate the amount of organic waste delivered to the facility.
