

Complimentary tickets from the Disneyland Resort

The tickets are valid only for active California firefighters, and may not be sold/transferred to or used by anyone else. Each firefighter is limited to two (2) tickets for admission of himself/herself and a guest. Both a California firefighter department-issued ID and a government-issued photo ID (e.g.: passport or driver's license) must be presented for use of each pair of tickets. Firefighter guests may not use the tickets without being accompanied by the firefighter. Sale or transfer of the tickets in violation of these conditions could result in the tickets being voided and admission being refused. Tickets are only valid for use on Mondays through Thursdays and expire May 10, 2018. Blockout days include all Fridays through Sundays, plus 2/19/18, and 3/23/18–4/8/18.

^{*}Each ticket is valued at \$167. Please distribute these tickets in accordance with Section 18944.1 of the Regulations adopted by the Fair and Political Practices Commission ("FPPC") and your local policy, and comply with the posting requirements of these rules by reporting tickets on FPPC Form 802. Consistent with FPPC rules, the tickets are not earmarked by the Disneyland Resort for use by any specific agency official.
